Sir,

1. In line with the insidious utterance made by Smti Kriti Singh Debbarmann, BJP candidate from 2-Tripura East (ST) PC, whose remark is in record that “*CPI(M) is a party of human killer*”, now Biplab Kumar Deb, BJP candidate from Tripura West PC has resorted to the same baseless vilification campaign in the election campaign in 2-Tripura East (ST) PC.

In the attached copy of the Digital page of Syandan Patrika dated 22<sup>nd</sup> April, 2024, it reports that on the same day, while addressing at rally at Kalyanpur of Teliamura Sub-Division (27-Kalyanpur-Pramodenagar AC) Biplab Kumar Deb said.

*“ Communists are blood-thirsty. The Communists would consume proceeds from sell of poor’s blood. Their profession is to live on selling off the poor. They don’t only sell them, they also snatch lives of the poor.”* Digital link below : <https://syandanpatrika.in/rajya/article-46821>.

While the Sub-rule ‘V’ of Part (B) of rule 4.4.2 Sub-Chapter “Don’ts” under caption ‘Electioneering by parties and candidates’ of the Model Code of Conduct prohibits “**No criticism of other parties or their workers on the basis of unverified allegations or on distortions**”, by making such baseless slandering, he grossly violated the Model code of conduct.

2. On 22<sup>nd</sup> April, 2024 Sri Biplab Kumar Deb while addressing another meeting at Teliamura, he made most provocative and violent direction to his followers targeting Sudip Roy Barman, INDIA Bloc leader, saying “*He (Sudip Roy Barman) would be straightened in such way that, he would not be able to take water in his mouth to drink. He would be buried so deep under the ground, that his head and legs cannot not be traced. ... he has been dong to much excesses*”

May I request you to verify his remarks with your own agencies and on the event the allegations found to be fact, suspend him from any election campaign for a particular period. This is necessary for keeping decency and not to further vitiate the campaign in 2-Tripura East (ST) constituency in rest of the time.

On 22<sup>nd</sup> April, 2024, Sri Ratan Lal Nath, Minister and BJP leader while addressing an election rally at Cherna of 25 Khowai A/C, he declared reward of rupees two lakh to the booth which would record highest casting. This is an open provocation of false voting. We apprehend, Sri Nath had encouraged in such way to raise polling percentage to 109% in Booth No. 38 of 2-Mohanpur AC, which happens to be his own constituency.
