Re: Post poll violence and attack on opposition throughout the State

We place on record our deep gratitude for the time you have allotted to the delegation of the opposition political parties to listen their grievances in connection with ever increasing physical attack on opposition and deteriorating law and order situation in West Bengal, particularly after the declaration of results of the Assembly Election on 19th May 2016.

- 1. Sir, you are aware that violence has been institutionalized in West Bengal during the last 5 years and more specifically after the Panchayat Election of 2013. Such violence is multi-dimensional in the form of eviction from houses and locality, damage to the houses, attack on livelihood, registering false police cases, murderous attack, etc. against opposition political activists by miscreants of AITC. All opposition political parties like CPI(M), INC, BJP, RSP, AIFB, CPI, SUCI(C), CPI(ML) and others have borne the brunt of such brutal attacks.
- 2. There has been accentuation in such attack after the Lok Sabha Election 2014. It assumed shameless proportions during the Municipal Election of 2015. There were mounting attacks on the opposition political parties in all parts of West Bengal including Kolkata and Bidhannagar Municipal Corporation areas. The entire Municipal Election process was reduced to a farce when polling booths were openly captured, the agents of opposition political parties were driven away and even voters were driven away by intimidation. These were in addition to the murderous assaults and other

Fax: 2264-0721 2265-0932 forms of violent action let loose by AITC. Such subversion of democracy had also resulted in forcible removal of the then State Election Commissioner, S. R. Upadhyay who was illegally confined in the State Election office by the senior AITC leaders including State Cabinet Ministers.

- 3. Such uncontrolled habituation with the politics of violence has encouraged AITC to embrace that path ever since the election process for 2016 Assembly Election was initiated. All the opposition political parties have drawn the attention of ECI to the violent methods adopted by AITC in different parts of the State with specific documents and information. It is needless to repeat that acting on such document-based complaint ECI had initiated a number of steps including removal of partisan Bureaucrats and Police officers for ensuring free and fair poll. However, due to the lack of proper will of the officers in general and Police Administration, violence by AITC could not be stopped during the election process in different Districts of West Bengal. Such violence has claimed innocent lives, including the life of polling agents and opposition political activists. People were kidnapped and forced to leave their houses under threat of AITC hooligans. Even innocent children were not spared from such attacks. A summary of such incidents are provided in Annexure 1 & 2 of this memorandum.
- 4. You are aware that the Chief Minister of West Bengal has herself led the charge of the AITC brigade in issuing threats to ECI and Government officials to prevent them from acting impartially as is expected from them by the Constitution and Election Manual of India. The Chief Minister of West Bengal has also openly warned that she would retaliate inch by inch once the result was announced. We have seen a faithful execution of such threat by activists of AITC in almost all the Districts of West Bengal. countless attacks on the opposition political activists. More than 500 offices of different opposition political parties and mass organizations have been looted, burnt, forcibly occupied by the AITC men. Fresh evictions from houses in localities after localities are occurring. Huge amounts are being extorted as ransom and fine. Countless murderous attacks have been inflicted. Even cycles, drinking water connection or other facilities given earlier by the government are now being snatched away. Feuding AITC factions are contributing to further deterioration in law and order situation. West Bengal has reached such a condition today that the entire law and order machinery has broken down, making it impossible for citizens to live in

peace and security. Police administration is ineffective because it is afraid to take any cognizable action in view of the open threat issued by the Chief Minister herself. Some of such incidents are given in Annexure 3 of this memorandum.

In the above backdrop, we have come to you, the Constitutional Head of the State, to ensure peace, protection of life of citizens irrespective of political affiliation and ensuring normal political activities by all the political parties irrespective of the outcome of Assembly Election. Such intervention from you is required for restoring peace and democratic environment in the interest of West Bengal. We have full confidence that you will exercise your constitutional authority in ensuring an end to this anarchic state.

# Narratives of Violence by AITC During and after Poll

 10 persons have so far lost their lives in post poll violence; two of them were polling agents. In Haroa, North 24 Parganas, Nur Islam Mistry was attacked with sharp swords by AITC goons on 18<sup>th</sup> April 2016. He died in hospital on 20<sup>th</sup> April.

In Domkal, Murshidabad, Tahidul Islam was brutally murdered by AITC gangsters on polling day (21.04.16). He was a polling agent for the CPI(M) candidate at Nutunpara Primary school.

In Bardhaman District, 2 CPI(M) workers and 1 Congress worker were killed by AITC goons. The CPI(M) workers were Sk. Fazal haque, election agent for CPI(M) at Khandaghosh Assembly Constituency and Dulhiram Dal whose son was a polling agent in the same constituency. The Congress workers Khondakar Ali Hossain was killed at Math Nurpur Village, Raina PS.

In Maldaha District 4 AITC workers were killed in an explosion while they were preparing bombs at Joinpur Village under Kumbhira Gram Panchayat.

2. At least 9 offices of CPI(M) and other Left parties were ransacked. In at least 84 incidents spread over 14 districts, houses and workplaces of CPI(M) workers were attacked, including some incidents where whole villages were attacked. There are Cases of arson, kidnapping, grievous injuries involving at least 158 persons.



# West Bengal 16<sup>th</sup> Assembly Election – 2016

### Incidents of violence by AITC during and after counting

During and after counting of votes cast in WB Assembly election, widespread violence all over West Bengal has been perpetrated by AITC gangsters. They have targeted the offices of opposition political parties and mass organizations including LF parties and the Congress, residence and workplaces of leaders and workers of these opposition parties. The acts of violence include physical attacks, damages of property, throwing of bombs and arson. Extortion of huge amount of money as ransom and fine is continuing and increasing day by day.

All the districts are affected. Here is a list of some of the incidents. There are many more. Even the senior leaders of the State like Madan Ghosh, the Central Committee member of CPI(M), Smt. Roopa Ganguli, the senior leader of BJP, Saktimohan Malik, former MP, Dinesh Dakua, the ex-Minister, etc. are also not spared.

#### 1. COOCHBEHAR DISTRICT

Over 100 heads of cattle have been taken away by attackers at different places. More than 200 shops have been looted and shut down. In more than 30 cases, attackers have occupied landed property. More than 1000 persons were forced to part with large sums of money imposed as 'fine'.

Party offices attacked: 4 CPI(M) offices have been attacked at Dinhata and Sitai and another one in Bakshirhat in Tufangunj. In Marichbari area of Coochbehar North Constituency, offices of CPI (M), Forward Block and INC have been ransacked. Apart from previously captured party offices fresh attacks and captures have taken place after the counting in Mathabhanga Kurashar Hat and other places. Altogether 40 offices of political parties and mass organizations have been damaged in the District.

Attack on residence: House of Comrade Dinesh Dakua, ex-Minister and Comrade Debashish Dutta within Mathabhanga AC were attacked and property damaged. Rural areas within this constituency are also being attacked. In Sitalkuchi AC cattle are being lifted from houses of left supporters. The residences of Namodipti Adhikay and Harish Barman were ransacked. There are continuous threats in many areas. In Dinhata AITC goons threw stones on the residences of AIFB candidate Akshay Takhur and CPI(M) leader Biswanath Chowdhury. Altogether 433 houses in the District have been attacked.

#### 2. UTTAR DINAJPUR

Attack on livelihood: There is total attack by AITC goons on the livelihood of workers and supporters of the CPI(M) and other parties of the Left Front. Many of them work in tea gardens but they are not being allowed to collect tea leaves and are thus being deprived of income.

Attack on residence: Nearly 200 families have lost all their belongings when their houses were ransacked in the GP areas of Chutiakhor, Sujali and Ghirnigaon in 28-Chopra AC which bears the main brunt of the attack. 34-Kaliaganj (SC) AC and 36-Itahar AC are also affected.

Assaults: Attacks on CPI(M) workers on streets and public places are frequent. Their motor bikes and cycles have been forcibly taken away in many cases. Many CPI(M) offices have been forcibly shut down.

Attacks on Elected Panchayats: The GPs and PS which were formed by the Left Front after the 2013 Elections have been attacked and their offices closed down by the AITC goons.

3. Dakshin Dinajpur: Raju Das of Tapan Block was beaten up by AITC hooligans and was admitted to Malda Hospital with serious injuries.

#### 4. NADIA

Attacks on Offices: Several CPI(M) offices at Hanskhali, Kalyani, Gayeshpur, Gokulpur, Shimurali, Chakdaha and Haringhata have been attacked and the belongings including furniture either destroyed or thrown out.

Attacks on residence: At Saguna in 92-Kalyani (SC) AC, Alok Sarkar's house was ransacked. The houses of other party supporters were attacked and damaged at Rathtala and Bidhan Palli in Kalyani. In 91-Chakdaha AC, the house of Gautam Nandi in Ward No.16 was attacked and his mother, wife and baby daughter were forced to leave. Other party workers whose houses were attacked include Biswanath Sarkar and Tapas Dam. At Palpara, 10 party workers were thrown out of their houses. The residence of Debatosh Dhar (Ward No.18), Sayan Mali (Ward No.6), Haru Dutta and Subhamay Dutta (Rajbagan area in Ward No.2) and about 12 others were attacked. In 90-Ranaghat Dakshin (SC) AC, 3 houses of party workers were damaged. In 89-Ranaghat Uttar Purba (SC) AC, armed AITC thugs entered the house of CPI(M) worker, Krishnendu Biswas in Mamjoan area and threatened him. At Haringhata, Lalan Giri was severely beaten up because his sons campaigned for Left Front.

Within Ranaghat AC planned attacks on houses of CPI(M) activists and supporters started at Gangnapur, Gopinagar, Hijuli, Anantapur, Majhergram after a meeting was held by Abir Biswas at Gangnapur Community Hall encouraging AITC workers to post poll violence. At Anandapur Bhaumikpara, houses of Jayanta Bhaumik and Narayan Das were damaged.

Bankim Ghosh, CPI(M) leader and former Minister had an office on his own property. This was forcibly occupied by AITC which has raised its own flag there.

Attack on livelihood: At Hatishala in 82-Chapra AC, the garment shop owned by Sarafat Sk., a CPI(M) supporter was plundered. In Muslimpara of Chapra, the AITC goons are carrying on a reign of terror. On 21<sup>st</sup> May a Congress worker Akbar Mondal who had campaign for CPI(M) candidate at Chapra AC was beaten up at Mandira. At Hantra within the same AC 22 Left workers have left home, including 3 polling agents.

#### 5. NORTH 24 PARGANAS DISTRICT

Party offices attacked: At least 4 CPI(M) offices in Arjunpur area of Rajarhat PS were vandalized by AITC hooligans. In 102 Amdanga AC AITC antisocial are carrying on atrocious activities in Duttapukur area. Many of the party offices were ransacked between 19<sup>th</sup> May and 21<sup>st</sup> May. Within Sandeshkhali Block-2, a CPI office was damaged in Khulana GP.

Attack on residence: In the Amarpalli area of Naihati PS, houses of CPI(M) supporters were attacked, they were physically assaulted and forcibly driven out. At Barasat Block-2, another CPI(M) office was ransacked by a large number of AITC hooligans. In Hingalganj Block, about 60 ration cards have been taken away at Sandelbil GP.

Physical Assault: In Madhyamgram AC Subodh Mistri, polling agent at polling station No. 212, Kalam Mistri of No. 214, Jakir Ali and Sk. Bablu of No 217 and Mihir Ali of No. 216 were severely assaulted. In Bangaon AC several CPI(M) offices have been attacked. In Duttapukur area of 102-Amdanga AC the houses of Sripada Das, Goutam Das, Liton Basu, Sanjoy Basu, Mur Ali, Manik Majumder, Nauser Ali were attacked. Liton Basu's mother was also brutally beaten up. All the attacks were led by Meghnath Das, AITC pradhan of Kashimpur GP. Duttapukur PS was informed but failed to control this situation.

In 122-Minakhan AC ever since the declaration of the result on 19<sup>th</sup> May, armed AITC hooligans are vandalizing houses of CPI(M) Polling agents, activists, supporters and even general electors who dared to cast their votes in the said election. A huge number of CPI(M) Polling agents, workers and supporters have been rendered homeless. Many others have been brutally assaulted. Female members of our Party and female members of the families of some of our members and supporters have been assaulted. Even a little baby was not spared of the attacks of these hooligans.

Plight of Samadhan Applicants: Many CPI(M) leaders, activists, supporters and even general electors had lodged complaints to the Election Commission through the Samadhan application. But unfortunately, all the details of the complaints lodged over the last two months or so and the identity and telephone numbers of the complainants are somehow being divulged to the ruling AITC and complainants are now receiving threat calls.

#### 6. SOUTH 24 PARGANAS DISTRICT

Party offices attacked: On 19<sup>th</sup> May, 2016, 6 CPI(M) offices were ransacked at Canning East, Sonarpur South, Sonarpur North, Baruipur West, Jadavpur, Bishnupur and in other areas. 4 RSP offices in Jharkhali PS area in Basanti were attacked and occupied. Congress office at Baruipur, Patharpratima, Canning Hospital crossing were damaged. At least 44 nos. of party offices have been occupied forcefully by AITC hooligans in the district.

Attack on residence: Residence of LF supporter Basudeb Pal at Nafarganj market was attacked. He and his wife were beaten and injured. The houses of Shajahan Laskar and Arjed Laskar at Nirdeshkhali, Basanti, house of Anath Mondal at Kheadaha, Sonarpur North, house of Congress leader Arnab Roy at Canning West were attacked and damaged. Houses of Manjur Molla (Beota Kajipara under KLC PS), Jiban Naskar (Hatgachha), Suman Mondal and Dinesh Naskar (Madhya Hatgachha under KLC PS), Asraf Molla and Abir Baidya (Binarhat under Bhangore PS), Mahiuddin Molla (Hariharpur under Bhangore PS), Akbar Biswas (Balipur under Bhangore PS) were attacked and looted or damaged. On 21st May AITC goons forcibly entered CPI(M) activist Abir Hossain's house (Mathurapur Village in Durgapur GP) and took away his motor bike. On the same day the house of Milan Bhattacharya at Shibkalinagar, Kakdwip was looted by AITC gangsters. In Basanti, the houses of at least 17 party leaders and activists have been attacked and ransacked. Residences of Noti Chaudhuri (Kanthalberia GP), Arshad Purkait, Abul Purkait, Afsar Purkait (Phulmalancha GP), all within the jurisdiction of Basanti PS were severely damaged. 3 houses of LF activists have been attacked in Sonarpur Uttar and 1 in Sonarpur Dakshin.

Party worker Ram Barman of Gosaba and Sachin Mondal of Bishnupur were physically assaulted. Intimidation, assault on LF workers and supporters and attack on their houses and shops by AITC goons are rampant in the area of Basanti, Gosaba, Sonarpur North, Baruipur East, Baruipur West, Jadavpur, Bishnupur, Falta, Bhangar, Canning East, Canning West, Magrahat West, Patharpratima, Kakdwip, Budgebudge areas of South 24 Parganas District. At Baruipur, Panchanan Das, a polling agent of the CPI(M) candidate, was beaten up by AITC criminals after the counting of votes. His wife was also beaten up and an attempt was made to set his shop on fire. An AITC gang led by Halim, AITC leader and Upapradhan of Shankarpur-II GP, assaulted CPI(M) worker, Kalo Sona and injured him. Many shops belonging to party workers and supporters have been looted and ransacked. These include the grocery shop of Rasik Mondal at Ramkrishna Palli and the vegetable shop of Khokan at Betberia in Baruipur. In 146-Bishnupur (SC) AC, CPI(M) workers of Chakrasul Mamudpur have been beaten up. On 21st May, 6 CPI(M) workers including 1 woman were badly beaten up. The woman, Arati Manna, has received severe head injury. On the same day, 4 CPI(M) workers were beaten up elsewhere in Patharpratima.

Numerous shops belonging to workers and supporters of the Left Front have been looted or forcibly shut down, thus depriving them of their whole income. Similarly, the shop of

Kamasujjaman within Bhangore PS was looted and ransacked by AITC goons on 20<sup>th</sup> May.

These are only few. In many of the GP areas more than 100 houses have been attacked and ransacked. Hundreds of our supporters have to leave away from their residence. Extraction of money and imposition of fine is huge. All these are continuing.

Even in Jadavpur area within KMC, attack and ransack is continuing. Many of our supporters are not allowed their livelihood or work in workplace. Shops are getting closed or occupied. Numbers of our workers are admitted in hospital for treatment.

#### 7. KOLKATA DISTRICT

Party offices attacked: Kashipur- Belgachia Zonal office of CPI(M) at B T Road was forcibly locked by AITC goons. CPI(M) LC office at Sarkar Bazar was ransacked and Party office at Sukanta Sarani has been captured by AITC goons. CPI(M) offices at Convent Lane in 163-Entally AC and CITU Union office in 167-Maniktala AC were attacked and ransacked. On 23<sup>rd</sup> May, Ultadanga Zonal Committee office of CPI(M) has been captured.

AITC hoodlums physically assaulted Sujit Sen on 20<sup>th</sup> May and beat him up. The family of Bina Ghosh and Biplab Ghosh were also beaten up at night on 19<sup>th</sup> May. Md Javed residing at Meher Manjil under Gardenreach PS was similarly beaten up on 21<sup>st</sup> May. All these incidents took place within 158-Kolkata Port AC. At ward No. 9 in Shyampukur AC CPI(M) activists Babla Roy was beaten by AITC goons they did not spare Biman Das a 17 year old CPI(M) supporter. In Kasba AC, on the night of 19<sup>th</sup> May three small shops belonging to CPI(M) supporter near Ballygunge Rail Station were ransacked and damaged by AITC thugs. The same night they shut down forcibly a CPI(M) office at Bosepukur Bazar. Several branch, zonal and local offices of CPI(M) were attacked and ransacked all over Kolkata.

Attack on residence: residence of Sanju, Secy, Sarkar Bazaar LC was ransacked. 5-7 party members were brutally assaulted at Sukanta Sarani office in ward no 30.

On 20<sup>th</sup> May, the house of Md. Nizamuddin, CPI(M) leader and former MLA, was attacked by AITC goons numbering about 50. The houses of 2 CPI(M) supporters in the same locality were also attacked and ransacked. These incidents took place within 161 Ballygunge AC. On the same day at about 9-30pm the house of CPI(M) leader Mrinal Roy Chowdhury within 164-Beleghata AC was attacked by a mob of about 250 AITC thugs. The mob attack went on for four hours at night. They set part of the house on fire by throwing acid bulbs. In various areas of the 149-Kasba AC the houses of four CPI(M) activists were attacked by armed and drunken AITC goons. The victims are Rabi Das, Prasanta Ghosh, Sukanta Das and Kamal Chakraborty. In ward No. 108 in the same AC the house of a CPI(M) leader Basudeb Basu was attacked. Even the house of Satarup Ghosh, candidate from Kasba AC was attacked on 21<sup>st</sup> May.

#### 8. HOWRAH DISTRICT

Party offices attacked: In Bally AC, Liluah LC-1 office at Liluah PS, Chaitalpara and Bhotbathan Party office were ransacked by TMC goons. Party office at Ghoradaha village, CPI(M) LC office of Bargachia and 3 other party offices were attacked damaged. One trade union office and a party office in ward 46 are ransacked by AITC thugs.

Under Jagatballavpur PS 4 CPI(M) offices at Ichanagari, Naikuli, Bargachia and Munsirhat were looted. Under Amta PS a CPI(M) office at Gajipur was ransacked.

Attack on residence: Bombs were hurled at the house of Gayetri Pandey, Panchayat member under Domjur AC. Bike was damaged. In Burunda village of Bagnan AC Lakshmi Panda, CPI(M) polling agent and his wife, Chanda Panda were mercilessly beaten, their house was attacked and ransacked. House of Gopal Goswami and others were also ransacked by AITC goons. Milk depot run a party worker at B Garden was attacked. Bricks were thrown to the house of Dulal Chakraborty, party worker at B Garden. The house of Nurul Huda Mollah in Jagannathpur area under Jagatballvpur PS was attacked. 22 houses and shops were looted in the villages of Asanda, Ghola and Dihibhurst under Udaynarayanpur PS. 6 houses were completely looted at Manasri in Debipur GP. 25 Houses were ransacked at Abhirampur village under Udaynarayanpur PS while the police and the news media were forced to stay away. Property wroth about 2 lakhs rupees were looted from the house of Anwara Bibi at Khalna Paschim Para under Joypur PS. In the same PS boat men on the Bhatora were beaten up. In Bankra No 3 GP of Domjur AC Ananda Chatterjee's residence was attacked and brickbats were thrown on the house of Pradip Das. In Orfuli GP of Bagnan AC houses of CPI(M) activists were ransacked. The same thing happened in Chandrabhag GP of the same AC among those assaulted are Smt. Chanda Panda who is hospitalized, Kamal Rout, Srimanda Kazi and various other CPI(M) activists and sympathizers. At Par Kanpur in Amta AC Dulal Maity was beaten up by AITC thugs. At Kalyanpur within the same AC the houses of Local CPI(M) leader Bhaskar Roy and GP Pradhan Shyamali Kabiraj were vandalized. In Kupnandan village within Nakal GP of Shyampur AC Sk. Shorab's house was ransacked and his wife Ismatara Begum was beaten up. She had to be hospitalized. Debasish Samanta of Pakuria village was also physically assaulted. About 30 shops belonging to Left supporters all over Udayanarayanpur were ransacked by the goons and many residences attacked. In different part of Udayanarayanpur AC at least 17 persons were severely beaten up by the AITC hoodlums. Apart from them the women members of Amu Khan's family in Kurchi village were beaten up. Under Bally PS the residences of CPI(M) leaders Rajen Roy and Samiran Chatterjee and activists Sanku Das, Sankar Jana and Menoka Chatterjee were raided.

Physical Assault: In Paschim Marit area under Amta PS Akbar was assaulted in his house by AITC criminals who broke its doors and windows. A Gajipur under Amta PS a Congress activists Ranabir Singha and his wife were beaten up. She received eye injuries.

#### 10. PURBA MEDINIPUR DISTRICT

212-Pataspur AC: On 19<sup>th</sup> May evening CPI(M) office at Monglamaro was attacked, all the furniture moved out and burnt. In Argoal and Singhda areas AITC goons are moving from house to house who threaten CPI(M) workers and supporters. Some of them are being beaten up and others forced to join AITC rally.

215-Khejuri AC: Upto 21<sup>st</sup> May 55 places of residence and 7 shops are being ransacked and 3 shops occupied. 5 CPI(M) offices were damaged and 10 persons physically assaulted. 65 people have been forced to leave their house.

213-Kathi Uttar AC: In Sunia, Amtolia and Kalinagar areas house to house threats are going on and fines being levied. 10 shops have been looted and 5 shops shut down. There are 132 new refugees. 3 fishermen were forced to stop work. Extensive areas including Kanaidighi are subject to terror. 40 CPI supporters had to leave home.

206 Moyna AC: On 19th May at 8pm offices of RSP, CPI and ABPTA were broken into and looted.

205 Panskura Paschim AC: Sanu Ali a member of the CPI(M) was kidnapped from the Myshora area and severely beaten. His hands and legs have been fractured and he is under treatment at Tamluk District Hospital. 3 CPI(M) offices have been occupied.

209 Haldia AC: AITC set their own party office at the Haldia Township on fire and at Durgachak they damaged their own office and blamed CPI(M) to create unrest. 8 persons from Haldia and 11 persons from Durgachak (including Tapasi Mondal the newly elected MLA) belonging to CPI(M) have been falsely charged. CPI(M) Zonal Committee office was looted and damaged on 23<sup>rd</sup> May.

214-Bhagabanpur AC: CITU office destroyed at Mugberia and 32 places of residence ransacked. 2 shops have been looted and 17 shut down. 28 persons have been thrown out from home.

210-Nandigram AC: As late as this morning (23<sup>rd</sup> May) CPI(M) Zonal Committee office at Nandigram has been occupied. 15 houses ransacked so far and CPI(M) supporters are being constantly threatened. All over Nandigram Block-1, physical assaults, destruction of houses and arson are the order of the day. Sk. Saddam Ali, s/o former CPI MLA Ilias Mohammad, has been forced to leave home due to terror.

203-Tamluk AC: 3 shops were looted at Mecheda. At Santipur Anchal-1, shops of Left supporters have been damaged. Uttam Maiti, an INC supporter, and Jyotindra Jana of Milan Nagar Bazar under Tamluk PS were severely beaten up and had to be hospitalized.

.211-Chandipur AC: In Chowkhali area house to house threat are going on.

217-Ramnagar AC: AITC antisocials attacked the CITU office at Digha

#### 11. PASCHIM MEDINIPUR DISTRICT

Party offices attacked: In Medinipur City no-4 Party officewas gutted; Pingla Zonal office was ransacked; Jhargram City Zonal office attacked and ransacked, Dubra Party office of Jambani in Binpur and Daspur Zonal office (occupied), Panchghuri Branch Office were attacked and ransacked by AITC goons. 19/05/2016

AITC hooligans have captured many CPI(M) branch offices in Medinipur Town and the CPI office of the Town was vandalized. Offices of various mass organizations and trade unions were also ransacked.

Attack on residence: House of Shyamal Chakraborty in Sahara village of Pingla was attacked, he was assaulted. In Salboni houses of party workers of Mahasol Colony and Sholabandi were attacked; house of Laxmiram Hembram of Sidadihi was ransacked. Houses of Taibul Biswas LCM, Niranjan Pal of Panchghuri, Serafat mondal of Birsingpur were ransacked by AITC goons. Mahisdah & Faur village were attacked. Houses of Tarapada Bera of Retua Rajnagar, Bapi Pandit, Prasanta Digar, Panchanon Vhunia, Dibyendu Dhara, Sadhan Pandit were attacked and ransacked. Residence of Swapan Das Mahantaof Kadambandi village in Makli GP of Salboni was attacked. Swallow office in Daspur-2 occupied, shyam kundu of barkasempur village in sarberia was assaulted by AITC goons.

Physical Assault: In Ergoda region two persons of Sabar Community were severely beaten. In Narayangarh 10 CPI(M) workers were beaten.
